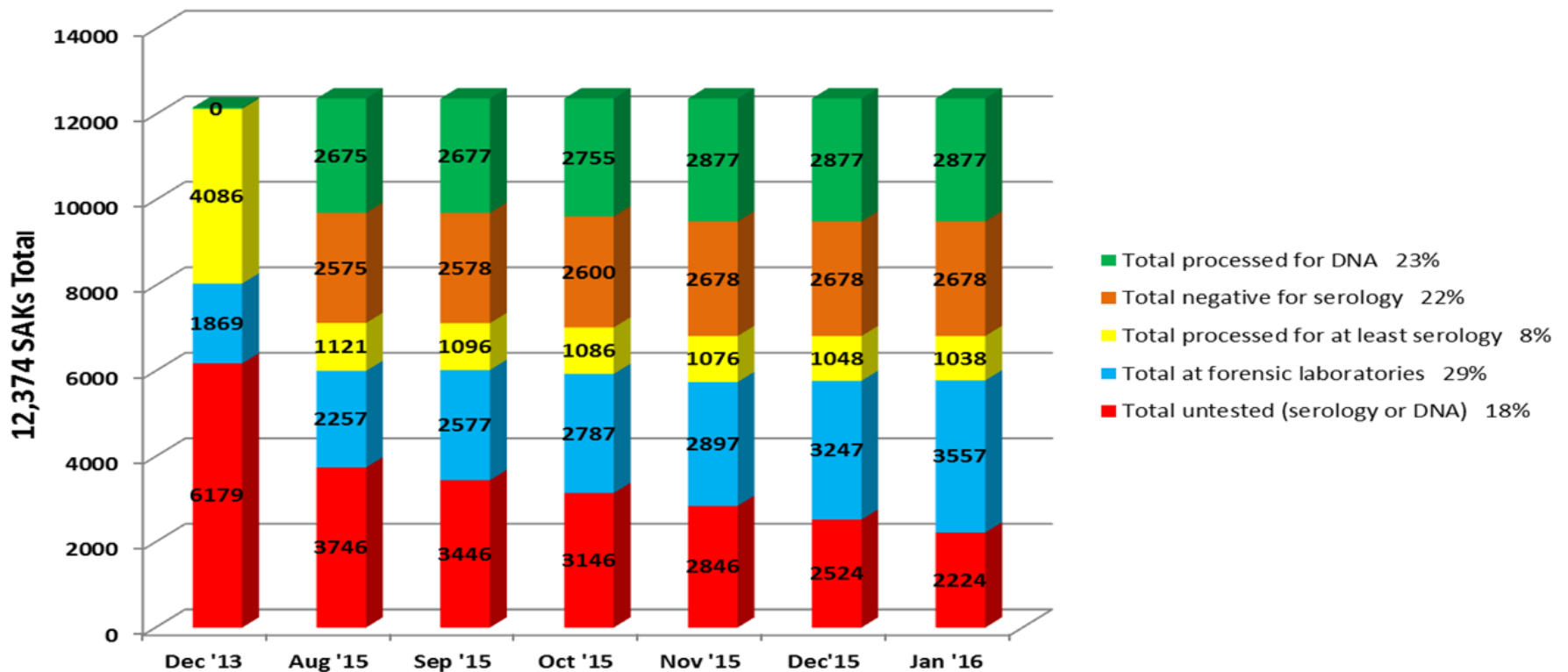

Investigation Results

870/877 Investigations have been initiated:

161/132 Investigations remain active: 15%

709/745 Investigations are closed: 85%

106/107 Individuals were identified that had been previously convicted of the crime: 14%

143/153 Requests for indictments have been completed against persons or DNA profiles: 21%

- **95/100** named suspects (40 multi case suspects) 65% of indictments
- **48/53** John Does (2 suspects on one case) 35% of indictments
 - **25/25** John Does are now named (7 multi case suspects) 47% of John Does
 - 1 Named John Doe is deceased

64/69 victims/suspects are deceased: 9%

- **10/14** suspects (does not include the deceased John Doe) 2%
- **54/55** victims: 7%

107/112 victims declined to participate: 15%

27/29 unable to locate victim: 4%

160/164 cases past the statute of limitations: 22%

13/20 prosecution declined: 3%

26/26 insufficient/degraded DNA: 3%

24/26 cases no crime occurred: 3%

40/40 consensual partner: 5%
