

Investigation Results As a result of DNA analysis (Cumulative Last Month/This Month)

614/681 investigations have been initiated:

163/185 investigations remain active: 27%


451/496 investigations are closed: 73%

76/83 individuals were identified that had been previously convicted of the crime: 17%

105/117 Requests for indictments have been completed against persons or DNA profiles: 24%

- 64/73 named suspects (27 multi case suspects) 62% of indictments
- 41/44 John Does (2 suspects on one case) 38% of indictments
 - 12/12 John Does are now named (7 multi case suspects) 20% of John Does
 - 1 John Doe is deceased
- 51/52 victims/suspects are deceased: 11%
 - 9/9 suspects (does not include the deceased John Doe) 2%
 - 42/43 victims: 9%
- 67/72 victims declined to participate: 15%
- 17/17 unable to locate victim: 3%
- 85/92 cases past the statute of limitations: 19%
- 0/1 prosecution declined: 0%
- 25/25 insufficient/degraded DNA: 6%
- 9/14 cases no crime occurred: 3%
- 17/24 consensual partner: 5%
