
## Status of Mayor Strickland's Executive Order

<b>/</b>	Investigate leads and examine all cases coming from testing of those kits	Progress: New investigations initiated every month. New indictments requested every month. MPD has a full time unit devoted to this project.
		<u>Progress:</u> SOP is reviewed and input is sought from Rape Crisis Center, Joyful Heart Foundation, and our national partners to make sure our efforts are victim centered.
	Prosecute to the fullest extent of the law individuals who are identified as suspects resulting from this additional forensic testing	Progress: Complete thorough investigations and present requests for indictments to the Shelby County District Attorney General on all cases that can be prosecuted. All cases that cannot be prosecuted are reviewed by SAK Working Group team members to make sure everyone is in agreement on prosecution of the case.
	Collaborate with, and participate in the national and state dialogue about best practices in in all areas related to matters of sexual assault;	Progress: SAK TF participates in national discussions and training through Summit for Cities Series, Joyful Heart Foundation, SAKI training, and the SAFER (Sexual Assault Facts, Education, and Response)

MSNM is meeting with small community groups at their location. MSNM is distributing awareness material to groups and coordinating a media campaign that includes radio and billboard advertisements.

#### Investigation Results MTD

2006/2077 Investigations have been initiated:

539/555 Investigations remain active: 27%

**1467/1522** Investigations are closed: 73%

217/235 Individuals were identified that had been previously convicted of the crime: 15%

220/228 Requests for indictments have been completed against persons or DNA profiles: 15%

- 139/146 named suspects (45 multi case suspects) 64% of indictments
- 81/82 John Does (2 suspects on one case) 36% of indictments
  - 26/26 John Does are now named (7 multi case suspects) 32% of John Does
  - 1 Named John Doe is deceased

147/156 victims/suspects are deceased: 10%

- 41/45 suspects (does not include the deceased John Doe) 3%
- 106/111 victims: 7%

155/155 victims declined to participate: 10%

49/52 unable to locate victim: 3%

306/309 cases past the statute of limitations: 20%

**91/95** prosecution declined: 6%

145/157 insufficient/degraded DNA: 10%

36/36 cases no crime occurred: 2%

48/48 consensual partner: 3%

#### **Prosecution Results**

#### John Eskridge, 52

2 Guilty Pleas March 2017

30 years at 100% for Aggravated Rape, 15 for each rape

Victims both agreed to plea deals

#### Rape 1: February, 2001

- Unknown male came up behind victim while walking, pulled a knife on her and pushed her over the railing onto the riverbank below
- Suspect raped and beat the victim and left after victim pretended to be unconscious
- CODIS Hit to John Eskridge

#### Rape 2: September, 2001

- Unknown male approached victim while she was at a gas station where victim declined needing any assistance
- Suspect jumped into the vehicle as she left the gas station, got control of the wheel, and forced the victim to drive to a deserted area
- Suspect raped her, beat victim, and stole her car
- CODIS DNA case to case association was found to John Eskridge

- 45 Sex Crimes Defendants with devices
- 13 Sex Crimes Victims with devices
- DV Project started July 6, 2016
- Expanded September 6, 2016
- 172 DV Defendants with devices
- 31 DV Victims with devices



- 262 Devices in Use
- 99 Total Arrests
- 44 Arrests in 2017
