The Memphis Alcohol Commission issues proof of compliance in the form of beer vendor card available through the City Permit Office for accost of $\$ 21.00$.
- C5 - No beer shall be sold or served to persons under legal age. A person must be 21 years of age to buy, consume or possess beer. The burden of ascertaining the correct age of minor customers shall be upon the owner, operator and employees of the business.
