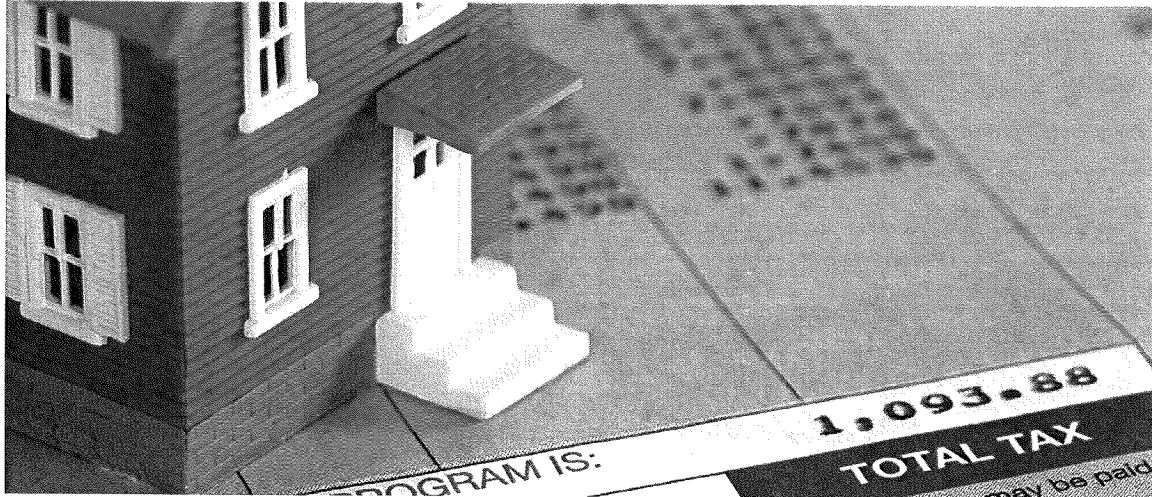

Quarterly for:

- Elderly Homeowners – no income limit.
