WHEREAS, the Council of the City of Memphis included funding for General Services – Fleet Services, as part of the FY 2023 Operating Budget; and

WHEREAS, the City of Memphis and GS – Fleet Services, like other cities are experiencing high and unpredictable inflation; and

WHEREAS, the City of Memphis' GS - Fleet find itself in need of additional funding for fuel and professional services to complete FY23; and

WHEREAS, the Fleet Fund has a Fund Balance to cover the needs of GS-Fleet's operations; and

WHEREAS, it is necessary to transfer allocations and appropriations totaling \$3,000,000 from Fleet's Fund Balance 0741-000000-039510 to various GS-Fleet Services service centers:
